THE TOPICS COVERED WILL INCLUDE: INTRODUCTION TO THE COURSE, WYOMING MINIMUM STANDARDS FOR HIRING, DEPARTMENTAL REJECTION CRITERIA, SETTING UP THE BACKGROUND INVESTIGATION FILE, CONDUCTING THE BACKGROUND INVESTIGATION, DOCUMENTATION, FINANCIAL RECORDS, AMERICANS WITH DISABILITIES ACT, AND WRITING THE BACKGROUND INVESTIGATION REPORT.
