PREFACE

The COVID-19 Pandemic that struck the world early in the year 2020 impacted lives in ways unseen in recent history. Sporting events and large gatherings were cancelled, schools were closed or went virtual, businesses closed or began operating under strict restrictions with limited indoor occupancies – and countless number of people died or were hospitalized after contracting the virus.

People essentially “shuttered-in” for a period and life’s everyday activities were either reduced or altered significantly. It would be logical to assume that the number of juvenile offenses in 2020 would decrease from previous years; however, the opposite was true. Although we have experienced a steady decline from 2015, underage and juvenile offenses involving alcohol in 2020 increased slightly from the previous year. Please refer to the Six-Year Trends Analysis on page 39 for more detailed information.

INTRODUCTION

Underage and binge drinking have become serious public health and safety concerns in every community in Wyoming – as they have throughout the rest of the country. Youth are beginning to drink at an earlier age, and they are drinking greater quantities than ever before. The increasing risk to Wyoming youth and communities prompted the Wyoming Association of Sheriffs and Chiefs of Police to begin collecting youth and alcohol-related data to develop more effective long-term strategies for law enforcement agencies and underage drinking prevention coalitions in Wyoming.

This data collection effort has been funded primarily with the use of federal grant funds provided by the Wyoming Department of Health. The grant funds received from the Wyoming Department of Health originally came from the United States Department of Justice - Office of Juvenile Justice and Delinquency Prevention as part of an existing national grant program entitled Enforcing Underage Drinking Laws. These federal grant funds were provided to the state of Wyoming since 1998 and were

administered by the Wyoming Department of Health – Mental Health and Substance Abuse Services Division. The OJJDP EUDL funding came to an end during 2013. The Wyoming Department of Health now provides grant funding to continue EUDL activities through a Substance Abuse and Mental Health Services Administration (SAMHSA) program entitled Strategic Prevention Framework Partnerships for Success.

Unlike other national prevention grant programs, these funds are specifically intended to be used for law enforcement initiatives which focus on effective enforcement of underage drinking laws. Due to the law enforcement focus of these federal grant funds, the Division began contracting with the Wyoming Association of Sheriffs and Chiefs of Police in 2006 to administer the grant process and to direct the efforts of the law enforcement agencies that apply for grant funding.

In 2007, the Association began to take a more strategic approach in the administration of these federal grant funds by implementing a statewide initiative that would involve multiple law enforcement agencies in a more directed

manner. The Wyoming Communities in Action initiative was designed to recruit and involve more law enforcement agencies in efforts to reduce underage drinking in their communities. The initiative was also intended to be the means by which more effective strategies could be devised, implemented, and evaluated – strategies which could then be shared, replicated and used by other agencies in the state.

An integral phase of this initiative involved devising a data collection process that would provide more complete, detailed information relative to incidents in which law enforcement encounters youth who are in possession of, or who have been drinking alcohol.

The process of identifying and selecting the data fields which would be useful for strategy development and evaluation purposes was a critical first step. Demographic information, location of law enforcement contact, time of day, arrests versus citations, blood alcohol concentration levels and determining the source of the alcohol were all selected and included in the data collection process employed by all participating agencies.

The data is collected daily, then tabulated and uploaded monthly to an online project management site. This information is then added to a master database and monthly reports are created for every grant agency – as well as included in an aggregated year-end report for all communities.

This report is comprised of data collected by twenty-three law enforcement agencies in Wyoming that participated in the grant-funded

program during calendar year 2020. Six counties, sixteen municipalities and the University of Wyoming now have a baseline of data relative to youth involvement with alcohol which can be used to assess and compare enforcement efforts and underage drinking prevention initiatives.

The data in this report represents ALL contacts by law enforcement with youth involving alcohol – not just contacts with youth during grant funded enforcement activities.

- This report is divided into three sections. The first section entitled COLLECTIVE COMMUNITY DATA provides aggregated alcohol-related statistics involving youth which was submitted by the twenty-three agencies that participated in 2020.
- The second section entitled INDIVIDUAL COMMUNITY DATA provides statistics for the following twenty-three agencies that participated in 2020: Big Horn County, Carbon County, Casper, Cheyenne, Douglas, Evanston, Gillette, Greybull, Hanna, Hot Springs County, Jackson, Lander, Laramie, Lincoln County, Moorcroft, Powell, Rawlins, Rock Springs, Sheridan, Teton County, Torrington, Uinta County, and the University of Wyoming.
- The third section entitled TRENDS ANALYSIS: 2015 – 2020 provides a six-year analysis of the fifteen agencies that submitted data for each of those six years.

COLLECTIVE COMMUNITY DATA

Although this report presents data from only twenty-three communities or counties in the state, these communities comprise more than half of the state's population. The community statistics, when aggregated, provides detailed information relative to Wyoming incidents in which law enforcement officers encountered youth who were in possession of, or who had been drinking alcohol.

The data in this report was collected during a twelve-month period (January 1, 2020 through December 31, 2020).

The statistics contained in this report provide a better understanding of alcohol use by youth in Wyoming than has been available before. Specific data regarding age, gender, time of day, charges, whether arrested or cited and released, location of offense and where the minor obtained alcohol is in this section of the report - information useful for prevention efforts, manpower deployment and strategy development.


An assortment of charts and graphs of aggregated data collected in the twenty-one communities are included in this report. Highlighted below are some significant, useful statistics:

- 1,155 underage youth were arrested or cited for involvement with alcohol.
- 80 adults over the age of 21 (male and female) were arrested during alcohol-involved incidents where underage drinkers were arrested.
- 20 juveniles were arrested and taken into custody – 269 were cited and released.
- Males age 18-20 accounted for the most arrests/citations – 507 (44%).
- Females age 18-20 were second in arrests and citations - 215 (19%).
- Males age 15-17 were third in arrests/citations – 127 (11%).
- Females age 15-17 were fourth in arrests/citations – 113 (10%).
- 27 males age 14 and under were cited or arrested.
- 23 females age 14 and under were cited or arrested.
- Average BAC: PBT – 0.085
- Law enforcement arrests involving youth and alcohol occurred more often between 10PM and 2AM - 555 (55%).
- 238 of the 1,155 total arrests occurred between 10PM and midnight, 357 occurred between midnight and 2AM, and 164 occurred between 2AM and 4AM.
- Minor in Possession was the most frequent charge – 886 of the total 1,155 underage arrests.
- There were numerous incidences of accompanying charges for interference, possession of controlled substance, assault, resisting arrest, disturbance.
- 58 underage youth were arrested for DUI (12 were juveniles 17 and under).
- Private Residences were most often involved – 499 (47% of the time).
- Minors reported they obtained alcohol from Party (76%) or Home (16%)




Juvenile Arrest/Custody vs. Cite/Release: 2020




Juvenile Arrests vs. Cite/Release: 2020



Total Reports: January - December 2020




Time Distribution: January - December 2020





Age Distribution: January - December 2020






Location of Offense: January - December 2020

SIX-YEAR TRENDS ANALYSIS


The statistics contained in this section represents data collected from fourteen law enforcement agencies that participated in this data-collection effort in each of the last six years, 2015 – 2020. The fourteen agencies included in this analysis are: Casper, Cheyenne, Douglas, Gillette, Jackson, Lander, Laramie, Lincoln County, Powell, Rawlins, Rock Springs, Sheridan, Torrington, and the University of Wyoming.

Enough data has been collected in these thirteen communities and one county during the last six years which can now be analyzed for identifying trends relative to youth's involvement with alcohol in Wyoming. The analysis of the data selected should prove useful for prevention efforts, manpower deployment and strategy development. Charts and Graphs that provide a visual perspective of current trends are included in this section of the report.


A REVIEW OF THE STATISTICS FOR THE LAST SIX YEARS REVEAL THE FOLLOWING TRENDS:

- Overall, underage offenses involving alcohol in Wyoming have decreased during the last six years from 1,208 in 2015 to 1,029 in 2020 - **although the number of underage offenses for 2020 increased by 104 from the underage offenses reported in 2019.**
- Overall, juvenile offenses involving alcohol in Wyoming have decreased during the last six years from 366 in 2015 to 246 in 2020 – **although the number of juvenile offenses for 2020 increased by 24 from the number of juvenile offenses reported in 2019.**
- Males and females between the ages of 18 to 20 continue to be the age group that accounts for the greatest number of underage arrests (an average of 510 male arrests and 246 female arrests each year).
- Males and females between the ages of 18 to 20 each showed a decrease in the number of arrests during the last six years (Males – 587 in 2015 to 507 in 2020) (Females – 252 in 2015 to 209 in 2020).
- Arrests for Minor in Possession account for the largest number of reported arrests – an average of 904 for 2015 through 2020. There were 812 arrests for MIP in 2020.
- The number of arrests for Public Intoxication for underage youth average 24 per year.
- Juveniles who are taken into custody account for a relatively small number of arrests compared to the number of juveniles who are cited and released by law enforcement – 6%.
- 10pm to 2am continues to be the time of day when the largest number of underage youths are arrested for alcohol involvement – with a significant number being arrested from 2am to 4am.
- Youth obtain alcohol from a party or home more often than any other source (average: 75% - party, 15% - home).


Underage Offenses Involving Alcohol: 2015-2020




Male Underage Offenses Involving Alcohol: 2015-2020




Female Underage Offenses Involving Alcohol: 2015-2020




Underage Offenses Involving Alcohol 2015-2020




Offenses Involving Youth & Alcohol 2015-2020




Juvenile Arrests vs. Cite/Release
